Terms of Business

We will require a deposit payment of £2000.00 plus any other extra services or disbursements on the estimate form at the time of making funeral arrangements. The deposit should be paid at the time of making arrangements or within 48 hours.

The arrangements made between you (instructor) and us (Funeral Director) form a legal binding contract and the person signing this confirmation is deemed fully responsible for the funeral account.

1. Estimate and expenses: Our estimate overleaf is an indication of the charges likely to be incurred on the basis of the information and details we know at the date of estimate. Whilst we make every effort to ensure the accuracy of the estimate, the charges are liable to alteration, particularly where third parties change their rates or charges. We may not know the amount of third party charges in advance of the funeral, however we will give you a best estimate of such charges on the written estimate. The actual amount of the charges will be detailed and shown in the final account. If you amend your instruction, we may need to make extra charges in accordance with prices published in our current price list.

2. Payment Arrangements: A deposit of the costs of the known disbursements is required in advance of the funeral, unless the account is being sent directly to a solicitor or bank.

Our surcharge may be deducted if payment in full, either by cheque/cash or debit card only, is received by us within 21 days of our account date. (This must be deducted at source, otherwise we cannot make a refund.) Thereafter, the surcharge will remain payable and interest of 2% (non-compounded) on the whole outstanding account will be added to the account on a monthly basis, starting at the expiry of one month of the account date.
